1. CALL TO ORDER:

Committee Chairman Wiseman called the Noise Committee meeting to order at 4:08 P.M. The meeting delay was due to technical issues.

7. EXECUTIVE DIRECTOR REPORT:

Airport Executive Director Barrett reported that for the month of October there was one commercial aircraft noise complaint, for the month of November there was one commercial and one military aircraft noise complaint, and for the month of December there were two commercial aircraft noise complaints. He said that in comparison to the previous year, the noise complaints were lower this year. Mr. Barrett said that the City Council would be reviewing the Airport's request to move forward with the Master Plan process at the City Council meeting that evening, and he said that as the Airport goes through the Master Plan process, it would be important for the Commissioners to report any feedback they receive from the community.

Committee Chairman Wiseman asked if the noise complaints were addressable or if they were the typical noise complaints that the Airport receives that are in regard to FAA flight path controlled issues that the Airport wouldn't have control over. Mr. Barrett confirmed that the noise complaints were the typical noise complaints that are received by the Airport. Committee Chairman Wiseman asked how the Committee could assist with the Master Plan Process. Mr. Barrett said that it would be important for the Commissioners to keep the community informed about the Master Plan process. Committee Chairman Wiseman asked if noise barriers could be recommended in the Master Plan. Mr. Barrett said that the Master Plan process would look at all noise suppressing procedures and options. Committee Chairman Wiseman said that it would be helpful for the Committee to receive historical noise records.
