SUBJECT: RECOMMEND CONSTRUCTION CONTRACT NO. 26P038 FOR PARKING ACCESS AND REVENUE CONTROL SYSTEMS AND CONTRACT SERVICES AGREEMENT NO. 26P039 FOR A PREBOOKING AND RESERVATION SYSTEM WITH SKIDATA, INC., FOR PALM SPRINGS INTERNATIONAL AIRPORT

### SUMMARY:

This action will recommend to the City Council to award Construction Agreement No. 26P038 for Parking Access and Revenue Control Systems (PARCS) for an amount not to exceed \$651,918 and Contract Services Agreement No. 26P039 for a Prebooking and Reservation System for an amount not to exceed \$43,780 with SKIDATA, Inc. for the Palm Springs International Airport (Airport).

### RECOMMENDATION:

1. Recommend the approval of Construction Agreement No. 26P038 for Parking Access and Revenue Control Systems (PARCS) to the City Council for an amount not to exceed \$651,918 for an initial five-year term commencing on April 9, 2026, and continuing through April 8, 2031.
2. Recommend the approval of Contract Services Agreement No. 26P039 for a Prebooking and Reservation System to the City Council for an amount not to exceed \$43,780 for an initial five-year term commencing on April 9, 2026, and continuing through April 8, 2031.

## BACKGROUND:

The Palm Springs International Airport seeks to enhance its Parking Access and Revenue Control System (PARCS). A Parking Access and Revenue Control System is a system designed to manage parking access, payment, and revenue collection for parking facilities. It automates the entry, exit, and payment processes, ensuring efficient management of parking operations. The Airport also seeks to implement an integrated Pre-Booking and Reservation System platform. A parking prebooking and reservation system is a digital platform that allows users to book parking spaces in advance. The system can be accessed from computers and mobile apps, providing real-time availability, booking options, and payment functionalities. These systems are crucial for enhancing the passenger experience, facilitating data-driven decision-making, and boosting non-aeronautical revenue.

The Airport consistently ranks among the fastest-growing airports in the U.S. In calendar year 2025, the Airport had approximately 3.31 million passengers, with over 1.65 million enplanements. Parking is a vital part of the Airport's ground access strategy and it's the second-largest source of non-airline revenue, generating over \$7 million annually from approximately 200,000 transactions from departing passengers, people parking to pick-up and drop-off passengers, Turo rental pick-ups, and Stay and Play guests. The average daily occupancy of the lot is 72% during the peak season, from October through May.

The Airport has four paid public parking lots; Parking Lots A, B, C, and D, that are open daily and provide a total of 880 parking spaces. Additionally, the Airport has an overflow parking lot that is opened for paid public parking when Parking Lots A through D have a remaining vacancy of 25 parking spaces. The overflow parking lot provides an additional 837 parking spaces.

For the last 26 years, the Airport has utilized contracted services to manage the Airport's parking access, revenue collection, and reporting. The Airport's current parking management company, ABM Aviation Inc., utilizes a SKIDATA Parking Access and Revenue Control System which is outdated, has reached the end of its useful life, and is creating operational challenges for the Airport.

Staff reached out to Ontario, Dallas Love Field, San Jose airports and various parking management companies, on what systems they have worked with and what worked and didn't work. SKIDATA, TIBA, and Amano were three most recommended systems.

## STAFF ANALYSIS:

The Department of Aviation worked with the Procurement and Contracting Department to issue a formal Request for Proposals (RFP) process to identify a qualified contractor for the needed services. The RFP was advertised in the local newspaper and published on the PlanetBids procurement platform. By the submission deadline of December 15, 2025, the City received six (6) proposals. Following a preliminary administrative review, three (3) proposals were deemed non-responsive for failing to meet the mandatory submittal

requirements. The remaining three (3) responsive firms were:

- Skidata, Inc. – Phoenix, AZ
- IP Parking NA, Inc. – Sterling, VA
- TIBA Parking Systems LLC – Anaheim, CA

The evaluation team made up of City staff from the Aviation and Information Technology Departments and a representative from the McGhee Tyson Airport - Knoxville, evaluated the proposals received against published criteria that included the firm's experience, the staff experience, the understanding of the scope of work, local preference, price, and interviews.

SKIDATA, Inc. was ranked the highest by the evaluation team and is being recommended for award of the contract. SKIDATA is part of ASSA ABLOY, the global leader in access solutions. SKIDATA USA has become the largest parking solution provider in North America, with an installed base of over 1,000 systems. Their solutions are deployed in airports, municipalities, off-airport parking operations, shopping centers, office complexes, universities, and medical centers across North America.

SKIDATA systems manage parking spaces across multiple U.S. airport installations.

Examples include:

- San Diego International Airport – over 9,000 parking spaces
- San Jose International Airport– over 5,000 parking spaces
- Dallas Love Field Airport – over 50,000 parking spaces
- Raleigh-Durham International Airport – over 10,000 parking spaces

The new PARCS is designed to maximize operational efficiency, reduce capital expenditure, and support the airport's long-term strategic and financial objectives. It will also provide reliable, cost-efficient, and innovative parking solutions tailored to Palm Springs International Airport's operational needs, which includes the following:

### **Reuse and Refurbishment of Existing Parking Gates**

Following an assessment of the Airport's existing entry gate infrastructure, SKIDATA proposed a cost-efficient approach to modernization. This strategy preserves valuable assets while delivering the performance and appearance of a newly deployed system by implementing the following:

- Reuse of existing gate mechanisms that remain structurally sound.
- Refurbishment using new LED Light Heads for advanced customer guidance. LED Light Heads are more efficient and durable, have better visibility, and longer lifespan.

### **License Plate Recognition (LPR) – The Ruby Camera**

The Ruby Camera is a cutting-edge License Plate Reader System that enhances video surveillance with its 4K resolution. It is designed for high-tech surveillance and includes the following:

- High-accuracy license plate recognition optimized for fast-moving, free-flow, and gateless environments.
- Seamless integration with SKIDATA Mobility Suite for ticketless entry, frictionless exit, and virtual credentialing.
- Encrypted data transmission ensuring secure handling of plate images and transaction data.

### **Power.Gate Plus.**

**Revenues**

CFC revenue is collected by the car rental concessionaires and remitted to the Airport according to state law to support the future consolidated rental car facility project. In March 2022, City Council approved a change in the collection methodology rate from \$10 per transaction to \$9 per day up to five days maximum.

YTD, revenues of \$4,514,205 represents 46% of the full year budget, reflecting seasonal nature of CFC revenues.



Fund 410 is the airports fund for passenger facility charges (PFC).

**Revenues**

The PFC, provides a source of additional capital to improve, expand, and repair the nation’s airport infrastructure. The FAA must approve any facility charges imposed on enplaning passengers. The PFC at PSP is \$4.50 and the maximum PFC charge on any one passenger travel ticket is capped at \$18.00.

YTD, revenues of \$3,690,109 represents 54% of the full year budget, reflecting seasonal nature of PFC revenues.

**Expenditures**

On July 18, 2019, the City of Palm Springs issued 2019 Airport Passenger Facility Charge Revenue Bonds for \$22,270,000 to finance a portion of the design, acquisition, and construction of ticketing hall and baggage handling system improvements. Interest is payable semiannually on June 1, and December 1 of each year, commencing December 1, 2019, until maturity or earlier redemption. FY 25-26 principal is \$1,865,000 and interest is \$633,750. Expenses to fund 410 include principal and interest and contractual services to the bond consultant.

The expense decrease for FY2026 reflects the reversal of FY2025 Loan Interest accruals.

Airport revenues included operating and non-operating revenues from airlines, fuel fees, terminal rentals, ground rentals, concessions, fines, parking, ground transportation, grant reimbursements, admission fees for the Palm Springs Air Museum and interest income.

**Expenditures**

Airport expenditures consist of personnel, contractual services, safety and security (Aircraft Rescue and Fire Fighting (ARFF) and law enforcement), utilities, maintenance, supplies, operating equipment, insurance, employee development, equipment rentals and repairs.

**Airline Revenue** all showed performance, collectively contributing to a 27% increase in total airline revenues over the prior year. Due to the implementation of Rates and Charges for FY2026.

**Non-Airline Revenue** grew by 9% over the prior year.

**Non-Aeronautical Ground Rental** declines 14% compared to FY24-25 primarily attributed to planned vacancy within the Accelerator Campus, the site was reallocated for aeronautical-related activities and City use.

**Non-Airline Term Rent Fee Retail** declines 13% compared to FY24-25 driven by a WHSmith reconciliation adjustment. The variance includes the application of their January payment.





**Revenues**

Airport Improvement Program (AIP) grants are offered to PSP to provide funding assistance for eligible capital projects that meet the criteria of the federal program. Additional funding is being distributed through AIP grant program by the Bipartisan Infrastructure Law (BIL). These grants have a 9.34% local share and the remaining 90.66% are reimbursed by the FAA. Revenues in excess of the Airport Operations & Maintenance are transferred to fund 416 to cover capital projects.

### **Capital Projects**

#### **Bono Concourse Escalators:**

**Background:** This project aims to replace the escalators leading to the Sonny Bono Concourse to reduce noise and improve operational uptime. Both Sonny Bono Concourse escalators were refurbished with in-truss replacements 9 years ago. At the request of the Airport Commission, the Executive Director of Aviation has directed Airport staff to research the costs and efforts required for a full replacement.

**Status:** In Progress

- Project Design & Finished (D&F) letter has been reviewed and approved by the airport staff.
- The project is in queue for production.

**Next Steps:**

- Escalator equipment manufacturing and delivery of material.

**Timeline:**

- Staff will provide manufacturing timeline once staff receive concrete dates from the vendor.

#### **Taxicab/Transportation Network Company (TNC) Shade Structures - Measure J Funds:**

**Background:** This project is one of the four capital improvement projects funded through Measure J. The project involves the design and installation of dedicated shade structures in the pick-up area for Taxicab services and TNC's, specifically Uber Technologies Inc. and Lyft Inc. The goal is to enhance passenger comfort and safety by providing protection from the elements, thereby contributing to a more positive transportation experience.

**Status:** In Progress

- During September 15, 2025, Commission meeting, Executive Director presented Measure J & Measure D staff recommendations, and three proposals were presented to the Commission. Commission advised moving forward with utilizing \$724,534 Measure J funds for design and installation of three shade structures at the TNC pick-up area.
- Staff have submitted permit documents for a Certificate of Appropriateness.

**Next Steps:**

- Staff present project documents to Historical Site Preservation Board (HSPB) for their input and approval.

**Timeline:**

- HSPB presentation is scheduled for April 7, 2026.

**Outbound Baggage Handling System Replacement:**

**Background:** This project is intended to modify or replace the existing outbound baggage handling system with a new system to improve capacity and efficiency, enhance baggage tracking through additional technology, reduce or eliminate single points of failure, and improve overall ergonomics for staff.

**Status:** In Progress


- Swinerton Builders (General Contractor) has been mobilized at the airport.
- Project team have started the site investigation and surveys.

**Next Steps:**

- General Contractor to finish 90% design drawings for the temporary baggage facility and submit for city staff review and approval.

**Timeline:**

- 90% design submission is expected to be completed by first week of April.



### **Restroom Renovations – Design Phase:**

**Background:** City Council approved the design and renovation of all public restrooms Airport-wide in the Fiscal Year 2023 budget. The project includes demolition and replacement of flooring and fixtures, upgrades to ventilation and lighting systems, and the conversion of select restrooms to gender neutral facilities.

**Status:** In Progress

- Design firm have submitted 90% of the construction documents for staff review.
- Engineering review is complete.

**Next Steps:**

- City Planning and Fire Review in progress.

**Timeline:**

- First submittal review is expected by March.

### **Purchase of (8) Plug-In Electric Vehicle (EV) Pickup Trucks & EV Chargers:**

**Background:** This project involves the procurement of eight (8) zero-emission pickup trucks and four (4) electric vehicle (EV) chargers to replace the existing gas-powered Airport fleet trucks. The purchase supports the Airport's efforts to minimize environmental impact. The project is funded by the Federal Aviation Administration (FAA) through the Airport Zero Emissions Vehicle (ZEV) and Infrastructure Pilot Program.

**Status:** In Progress

- All eight (8) trucks have been delivered to the city yard.

**Next Steps:**

- Trucks to be prepped for make-ready equipment and airport use.

**Timeline:**

- All trucks expected to be in service by April.



### **(80) Electric Vehicle Chargers Installation:**

**Background:** This project will install 80 Electric Vehicle Charging Systems (EVCS) at parking Lot-B located at the airport. The 80 EVCS consists of 39 dual port charger pedestals and (2) single port pedestals. This project is part of Southern California Edison (SCE) Charge Ready Program & SCE has provided site design and layout. SCE will complete the installation of load-side infrastructure and provide infrastructure to the stub up.

**Status:** In Progress

- Vendor selection for charger installation is complete.
- Pre-construction kick-off meeting scheduled for 3/10/26.

**Next Steps:**

- EV charger installation.

**Timeline:**

- Installation is expected to be completed by mid-April.

### **Hangar 18 Outfall Repair Project:**

**Background:** Project is to repair the damaged Stormwater Outfalls and damaged pavement due to hurricane Hilary. The scope includes the demolish of the existing security fence, the Stormwater Outfalls and the damaged pavement. Installing new concrete Stormwater Outfalls, new perimeter fence with the new standards.

**Status:** In Progress

- Project pre-construction meeting with the selected contractor was held in early February.
- Utility relocation is in progress.

**Next Steps:**

- Utility relocation complete and project mobilization.

**Timeline:**

- Utility relocation is expected to be completed in March.







### **550 S. Paseo Dorotea -Administration Building (Update)**

**Background:** Given the need for aeronautical space at the Airport to support existing and future tenants, the City Council approved the Airport to proceed with the purchase of 550 S. Paseo Dorotea for \$1.7 million dollars using Measure D dollars and airport revenues. The acquired building will become the administration offices for the Airport. The 8,665 square feet of mezzanine space in the Terminal building will be made available to existing or future tenants at a price per square foot to be negotiated.

**Report:** The Airport has completed the 60-day due diligence period and has reviewed the inspection report for 550 S. Paseo Dorotea. Items that require attention have been communicated to the seller and the Desert Springs Professional Office business park homeowner's association (HOA). The owner committed \$10,000 towards the repairs while the HOA is working on scheduling the roof repairs to be completed within 60 days of closing. Closing will not be delayed by the scheduled repairs. Closing is scheduled for Monday, March 30<sup>th</sup>. Closing documents will be transmitted electronically with execution via electronic signatures. The current occupants will remove all furniture and fixtures not part of the structure of the building by close of escrow.

Upon closing of escrow, the Airport will take possession of the building with expected occupancy to start on Wednesday, April 1<sup>st</sup>. City IT has indicated that they will need 30 days to complete the installation of all required technology. Existing furniture from the Airport will be relocated to 550 S. Paseo Dorotea in accordance with the move in schedule. Items identified that will need to be purchased include four (4) desks, three (3) monitors, a refrigerator and water dispenser. A wall to enclose open space in 550 S. Paseo Dorotea for Airport Security will need to be constructed and a door installed. This work will be done using an on-call contractor. Expected completion will be by May 1<sup>st</sup>.

The Airport will work on procuring a contract for janitorial services for 550 S. Paseo Dorotea. Until the janitorial services contact can be executed, Airport Maintenance will provide as needed cleaning of the building. The move in schedule will be phased as to minimize disruption to the operations of the Airport. The first group to move will be Capital Development on or about May 1<sup>st</sup> through 3<sup>rd</sup>. The second group will be Marketing and Communications, moving in on or about May 8<sup>th</sup> through 9<sup>th</sup>. The third group to move in will be the Executive Team on or about May 15<sup>th</sup> through 16<sup>th</sup>. Administration will be the fourth

group to move in on or about May 22<sup>nd</sup> through 24<sup>th</sup>. The final group will be Airport Security, Operations, and Emergency Management will move in on or about May 29<sup>th</sup> through May 31<sup>st</sup>.

### **Central Terminal Blank Space (Update)**

**Background:** The Airport has been evaluating opportunities to activate the currently vacant space in the Central Terminal lobby to enhance passenger experience while longer-term improvements for the area are developed.

**Report:** Airport staff recently completed additional improvements to the space to bring it to a more “ready for use” condition so that temporary activations could occur while the long-term concept is finalized. The area has now been cleaned and converted to a white shell condition that can support short term programming during the upcoming festival season. In partnership with FUSE, outreach is currently underway to brands and agencies to secure revenue generating activations tied to the Coachella and Stagecoach travel periods. The longer-term vision for space is to create a welcoming lounge environment that reflects the character and culture of the greater Coachella Valley while providing passengers with comfortable seating, charging stations, integrated flight information displays, and curated information highlighting local attractions and experiences. FUSE is currently advancing sponsorship discussions with potential partners, with Oak View Group and The Living Desert Zoo and Gardens emerging as leading candidates and Cotino being explored as a potential alternative. Sponsorship partners would be thoughtfully integrated into the overall design to ensure the space reflects the destination in an authentic way.

Airport staff, in coordination with FUSE and the Airport Marketing Committee, have been advancing the concept for activating the vacant Central Terminal lobby space through sponsorship and design development. On January 29, 2026, the Airport Marketing Committee met with staff and FUSE, reviewed the initial concept and suggested dedicated digital signage. On February 27, 2026, FUSE confirmed alignment with Airport staff on updated renderings and began working with Penwal to prepare construction plans and required submittals. On March 18, 2026, FUSE presented updated sponsorship and funding options to the Marketing Committee, and staff anticipate confirming a preferred sponsorship structure and final design direction within the next one to two weeks so the project can continue moving forward.

Fabrication has already begun on several primary elements of the space, including the large seating bench that will anchor the lounge area. Staff anticipate aligning a preferred sponsorship structure and final design direction within the next one to two weeks so the project can continue moving forward.
